**C I R C U L A R**


In reference to the subject captioned above, it is impressed upon all those MD/MS/ PG Diploma & M.Ch. Scholars (Batch 2022) that the decision taken in the Board of Postgraduate of studies in Medicine, Government Medical College, Srinagar all pre-requisites that include allotment of topic and clearance of Ethical Committee etc. are to be completed within a period of three months from the date of admission of the P.G. & M.Ch. Students (2022) enabling him/her to start work on the allotted topic immediately so that the P.G. scholars get ample time to complete their research work.

The decision taken by the Board, in this regard is reproduced hereunder in verbatim:-

*"After discussing the item, the Board unanimously resolved that topics allotted to the PG Scholar be first discussed in the Departmental Committee within 02 months from the date of their admission after last date of counselling before sending the topic to the Ethical Committee for its clearance. The Ethical Committee shall have to give its clearance within 03 months from the date of admission of the PG student to the course to enable him/her to start work on the topic immediately after 3<sup>rd</sup> month of admission. This step shall help the scholars to complete their work within time and also an opportunity for publication"*

It is, as such impressed upon all Heads of the Department, P.G. and M.Ch. guides that the decision taken by the Board is implemented in letter and spirit and ask the concerned PG (MS/MD) & M.Ch. Scholars to submit the gist of the synopsis to the Academic Section of this college and also sent soft copy of the same <sup>via</sup> mail on this address ([lr@gmcsrinagar@gmail.com](mailto:lr@gmcsrinagar@gmail.com)). However, the concerned Heads of the Department shall now expedite the process and ensure that the PG/M.Ch. Scholars of their respective departments submit gist of their synopsis at an earliest.
