
The tenure appointment of above doctors is on Academic Arrangement Basis and will be governed by the rules and regulations as envisaged in SO. 364 of 2020 Dated. 27-11-2020.

The appointment of the above doctors is further subject to the following terms and conditions: -

1. Before joining the Department, the selectees shall submit an affidavit duly attested by the Judicial Magistrate in the office of the Registrar Academics, Government Medical College, Srinagar to the effect that: -
  - a. They will not participate in any kind of strike during the period of their tenure engagement. In the event they proceeded on strike,

their tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.

- b. They shall remain disciplined during the tenure period, any kind of misconduct makes them liable for termination without any prior notice.
  - c. They are not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against them.
  - d. They shall not claim any experience certificate in case they leave Senior Resident post before completion of first year.
  - e. They will not indulge themselves in any private practice. In case they are found doing private practice their appointment shall be liable for termination without any notice.
2. The above doctors shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.
  3. The appointees are required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled. The selected candidates are supposed to submit their joining report to the office of the Registrar Academics, Government Medical College, Srinagar before they will be directed to report to the concerned Department.
  4. The Senior Residents appointed on an Academic Arrangement basis shall be paid as per SO. 365 of 2020 Dated. 27-11-2020.
