And if the Bounden discontinues the study or fails to complete the PG (MD/MS) Course to which he she was selected, the Bounden and Sureties shall forthwith pay to the Administration of Union Territory of Ladakh on demand the total amount of Rs. 50,00,000/- (Rupees Fifty Lakhs only) towards failure.

**PROVIDED** further that the Bounden and the Sureties do hereby agree that if the Bounden discontinues the study or after completion of the PG (MD/MS) Course of study to which he /she was selected, fails to serve the Administration of Union Territory of Ladakh for a period of 3 (Three) / 2 Two Years, it may be construed as professional misconduct and the fact reported to the National Medical Commission / Union Territory concerned for suitable action including cancellation of registration by the Council.

**PROVIDED** further that the bounden and the sureties do hereby agree that all sums found due to the Administration of Union Territory of Ladakh under or by virtue of this bond shall be recovered jointly and severally from them and their properties movable and immovable, as if such dues were arrears of land revenue under the provisions of Revenue Recovery Act for the lime being in force or in such other manner as the Administration of Union Territory of Ladakh may deem fit.
