WHEREAS; vide Endorsement No. HOD/Ortho/2022/719 Dated. 23-05-2022, the HOD Orthopaedics GMC Srinagar forwarded your application for grant of leave to undergo (12) months Fellowship in Orthopaedic Oncology and Joint reconstruction at Royal National Orthpaedic Hospital London;

AND WHEREAS; vide this Office letter No. GS-MC/L-Orth/1126 Dated. 25-05-2022 the matter was taken up with the Administrative Department (H&ME) for grant of permission in your favour to undergo aforesaid Fellowship programme;

AND WHEREAS; vide letter No. ME-Gztd/137/2022 (e-office) Dated. 27-06-2022, the Administrative Department (H&ME) asked this Office to intimate whether you are fulfilling the criteria, as laid down in Government Order No. 470-HME of 2013 Dated. 20-08-2013;

AND WHEREAS; vide this Office letter No. GS-MC/L-Orth/1663 Dated. 27-07-2022, the Administrative Department (H&ME) was informed that your case is not covered under Government Order No. 470-HME of 2013 Dated. 20-08-2013 as the said order regulates deputation/participation of Faculty members in short term National Scientific Conference/Symposia/Workshop etc upto a maximum of (15) days; while as the duration of your Fellowship programme is **ef** (12) months;

AND WHEREAS; vide No. HOD/Ortho/2022/1418 Dated. 02-08-2022, the HOD Orthopaedics GMC Srinagar while forwarding your leave form alongwith departure report informed that you left the Department on 26.07.2022 without any approval/NOC from the Administrative Department for pursing the fellowship at Royal National Orthopaedics Hospital, London w.e.f. 01-08-2022;

AND WHEREAS; vide letter No: GS-MC/L-Ortho/1761 dated: 05.08.2022, the above referred leave form alongwith departure report was forwarded to the Administrative Department for further instructions;

AND WHEREAS; vide letter No: ME-Gztd/137/2022 dated: 20.12.2022, the Administrative Department directed this office to issue final notice to you to résumé your duties within a week's time, failing which action as warranted under J & K CSR shall be initiated against you;

Now therefore, pursuant to the Administrative Department's directions conveyed vide No: ME-Gztd/137/2022 dated: 20.12.2022 a last and final opportunity is being provided to you to resume your duties within a week's time from the date issuance of this notice, failing which it shall be presumed that you are not interested to serve this Institution and recommendations for disciplinary action against you as per the provisions of Jammu and Kashmir Civil Services, (Classification, Control & Appeal), Rules 1956 will be made to the Administrative Department.
