Subject: Settlement of absence period of Mr. Dheeraj Kumar (Sanitation Worker) Bone and Joints Surgery Hospital Srinagar.

Order No. 69 AH of 2023 Dated: 27 /01/2023

Whereas, Mr. Dheeraj Kumar, Sanitation worker, Bone and Joints Hospital Srinagar remained unauthorizedly absent from duties w.e.f 02-06-2020 to 06-07-2020 and 18-01-2021 to 15-04-2021, i.e., 123 days;

Whereas, several explanations were sought from Mr. Dheeraj Kumar regarding his un-authorized absence from duties. However, he did not bother to reply.

Whereas, a Committee was constituted by this office vide No. 365 of 2022 Dated: 03-08-2022 issued under endorsement No. AH/EST-III/87/2727-30 Dated: 03-08-2022 to enquire into the un-authorized absence of Mr. Dheeraj Kumar, Sanitation worker;

Whereas, the committee in its meeting held on 13-08-2022 deliberated upon and examined the case in detail, but the official in question did not present himself before the constituted committee on the said date. However, the official presented his case on 13-09-2022 in detail regarding his un-authorized absence;

Whereas, the committee after following due procedure of enquiry recommended to treat the unauthorized absence period of Mr. Dheeraj Kumar w.e.f 02-06-2020 to 06-07-2020 and 18-01-2021 to 15-04-2021 as leave whatever kind due (excluding extraordinary leave) and remaining period of shortfall (if any) be treated as Dies-Non subject to the condition that the official was not involved in any subversive activities as well as he was not employed in any Govt./Private Sector. Besides, the concerned official shall be warned not to leave his place of posting on any occasion in future unauthorizedly for which disciplinary action shall be initiated against him as per law.

Whereas, the aforesaid official has furnished an affidavit duly attested by Judicial Magistrate deposing therein that during the period of absence he was not working in any Government/Semi Government Department /Private or in any autonomous body. Besides, he was not involved in any anti-national and subversive activity;

Whereas, the Chief Accounts Officer, Govt. Medical College Srinagar submitted earned leave account statement of the official, which reflects that only 87 days are at the credit of the official;
