AND WHEREAS, in terms of the Hon'ble CAT order dated: 19/11/2025 in the M.A./1593/2025 (Srinagar) in O.A. 189/2025, wherein this institution has been allowed to complete the process as regards two posts of child Psychologists except the category to which the petitioner belongs, accordingly provisional selection of one post has been reserved by this institution till final outcome of the writ petition.
