

Pursuant to the recommendations of Selection Committee which met on 17th December 2022 and verification of antecedents by Criminal Investigation Department (CID), Dr. Humaira Aslam, an In-service candidate, who has applied for the post of Demonstrator in the Department of Pathology, Government Medical Srinagar is provisionally engaged as Demonstrator, initially for a period of one year which is extendable upto (03) years on basis of good performance to be certified by the concerned HOD.

The appointment of the above doctor is further subject to the following terms and conditions:-

1. Before joining the Department the selected candidate shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
 - a. she will not participate in any kind of strike during the period of her tenure engagement. In the event she proceeded on strike, her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - b. she shall remain disciplined during the tenure period, any kind of misconduct make her liable for termination without any prior notice.
 - c. she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against her.
 - d. she shall not claim any experience certificate in case she leaves Demonstratorship before completion of first year.
 - e. she will not indulge herself in any private practice. In case she is found doing private practice her appointment shall be terminated without any notice.

2. The appointee is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled.
3. The appointee shall paid as per her LPC issued by her parent department.
