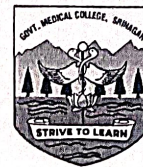

- 3) The salary in favor of the incumbent shall not be drawn and disbursed unless and until, satisfactory reports in respect of genuineness of Qualification certificate/Date of Birth certificate/Domicile certificate/Relevant category certificate (if any), is received from the concerned authorities/agency.

- 4) The engagement of the candidate shall be governed by the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 Dated: 27-11-2020.
- 5) The engagement of the candidates shall be subject to outcome of writ petition(s), if any, pending on the subject in any court of law or any competent jurisdiction.
- 6) The engagee shall give an undertaking in the shape of an affidavit duly attested by 1<sup>st</sup> Class Judicial Magistrate to the effect that if on verification, his/her Qualification/Date of Birth/Reserved category certificate from the concerned issuing authorities are found fake/forged, his/her engagement as "Medical Officer on Academic Arrangement Basis" in Govt. Medical College & Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her. In that case, he/she will not claim for any dues from the Govt. Medical College Srinagar (Already submitted by the incumbents in the office of the undersigned at the time of joining).
- 7) This arrangement is purely on temporary basis and shall not confer upon the candidates any special claim/right for their appointment against the said posts on regular basis as and when the same are filled under rules by the competent authority.
- 8) The candidates have already executed an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 Dated: 27-11-2020 to the effect that the engagement shall be for a period of one year or till the posts are filled up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.
- 9) The arrangement shall be regulated under other terms and conditions as specified in S.O. 364 Dated: 27-11-2020. The engagement so made on academic arrangement basis is for one year only from the date of engagement and shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the recruitment rules governing the posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
- 10) The engagee shall furnish the Medical Fitness Certificate issued by the competent authority to the office of the concerned Drawing and Disbursing Officer as mentioned above against each candidate.
