**Subject: Settlement of unauthorized absence period of Mr. Shobit Kumar, Sanitation Worker, Govt. Children Hospital Srinagar.**

Order No. *1052* AH of 2024  
Dated: *14/02/2024*

Whereas, Mr. Shobit Kumar, Sanitation Worker, Govt. Children Hospital Srinagar remained unauthorizedly absent from duties w.e.f 05-07-2023 to 11-08-2023 i.e., 38 days;

Whereas, Medical Superintendent, Govt. Children Hospital Srinagar allowed the official in-question to join back the duties on 12-08-2023 after an authorized absence of 38 days;

Whereas, Medical Superintendent, Govt. Children Hospital Srinagar vide his letter No. CHB/EST/III/2023/1464 Dated: 19-08-2023 forwarded the case to this office for settlement of unauthorized absence period of the erring official.

Whereas, a Review Committee was constituted by this office vide No. 995 of 2024 Dated: 24-01-2024 issued under endorsement No. AH/EST-I/ 2024/6990-7005 Dated: 24-01-2024 under the Chairmanship of Administrator Associated Hospitals Srinagar to enquire into the un-authorized absence of Mr. Mr. Shobit Kumar, Sanitation Worker, Govt. Children Hospital Srinagar;

Whereas, the committee in its meeting held on 29-01-2024 deliberated upon issue and examined the case in detail. The Medical Superintendent concerned was also consulted on the said date;

Whereas, the official in question has furnished an affidavit duly attested by 1<sup>st</sup> Class Judicial Magistrate deposing therein that the absenteeism happened only due to domestic problems;

Whereas, the Medical Superintendent, Govt. Children Hospital Srinagar submitted earned leave account statement of the official, which reflects that only 47 days are at the credit of the official;

Now, therefore, in light of the above, the period of unauthorized absence of Mr. Shobit Kumar, Sanitation Worker, Govt. Children Hospital Srinagar is settled/decided as under:

Period	To be treated as
05-07-2023 to 23-07-2023	19 days earned leave as communicated by Medical Superintendent, Govt. Children Hospital Srinagar.
24-07-2023 to 11-08-2023	Dies Non (19 days)

The official is strongly warned to remain careful and not to repeat such practice in future, failing which action as warranted under J&K Civil Service Rules shall be initiated against the concerned.
