The appointee shall report to the office of the Principal/ Dean Govt. Medical College Srinagar within a period of **twenty one (21) days** from the date of issuance of this order, failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only after the production of following certificates (In Original) to be verified subsequently:

- I. Date of Birth certificate.
- II. Qualification certificate(s).
- III. Domicile certificate.
- IV. Medical Fitness certificate from Chief Medical Officer (CMO), concerned.
- V. No Objection Certificate (NOC) from District Industries Centre(DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Counseling Centre, he/she shall relinquish the proprietorship of the unit/ enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/ She shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of the proprietorship and stakes, if any, in such self-employment unit enterprise and recovery to be made and also personally monitor its recovery.
- VI. Relevant category certificate, wherever applicable.
- VII. Any other document(s) as required under rules.

The appointment of the above candidate shall further be subject to the following terms and conditions:-

1. The salary of the appointee shall not be drawn and disbursed to him unless and until, satisfactory reports in respect of genuineness of Qualification certificate/ Date of Birth certificate/ relevant category certificate (if any), is received from the concerned authorities/ agency.
2. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated:-24-12-2009.
3. The appointee shall be on probation for a period of two (02) years.
4. The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.
5. The appointment in Divisional Cadre is non- transferable from one Division to another or from one Medical College to another.
6. The appointment of the appointee shall be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
7. The inter-seniority of the above appointee shall be as per the merit secured by him in selection process as indicated against him in the selection list furnished by the J&K Services Selection Board.
8. The appointee shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that if on verification, his Qualification/Date of Birth/Reserved category certificate(s) from the concerned issuing authorities are found fake/forged, his/her appointment as "X-Ray Assistant" in Govt. Medical College & Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her. He/she in that case will not claim for any dues from the Govt. Medical College Srinagar.
