2. The appointee(s) shall be allowed to join only after the production of following documents/certificates (In Original) to be verified subsequently:
 - I. Date of Birth certificate.
 - II. Qualification certificate(s).
 - III. Domicile certificate.
 - IV. Medical Fitness certificate from Chief Medical Officer (CMO), concerned.
 - V. No Objection Certificate (NOC) from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Counseling Centre, he/she shall relinquish the proprietorship of the unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of the proprietorship and stakes, if any, in such self-employment unit enterprise and recovery to be made and also personally monitor its recovery.
 - VI. Relevant category certificate, wherever applicable.
 - VII. Any other document(s) as required under rules.
3. The salary of the appointee(s) shall not be drawn and disbursed unless and until, satisfactory reports in respect of genuineness of Qualification certificate/Date of Birth certificate/Relevant category certificate (if any), is received from the concerned authorities/agency.
4. The appointment of the candidate(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated:-24-12-2009.
5. The appointee(s) shall be on probation for a period of two (02) years.
6. The appointment in Divisional Cadre is non-transferable from one Division to another or from one Medical College to another.
7. The appointment of the appointee(s) shall be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
8. The appointee(s) shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that if on verification, his/her Qualification/Date of Birth/Reserved category certificate from the concerned issuing authorities are found fake/forged, his/her appointment as "Carpenter" in Govt. Medical College & Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her. In that case he/she will not claim for any dues from the Govt. Medical College Srinagar.
9. That the appointment of the candidate is based on the provisional character and antecedents verification received from CID. If any adverse report is received during

the finality of the character and antecedents verification process through EVS Portal as per standing Government orders on the subject, the appointment shall be deemed to have cancelled ab-initio.
