
The candidate is directed to report to Nodal Officer, DTC, IMHANS-K for further duties.

Terms & Conditions:

1. The candidate must join his assignment within 7 days. Failure to do so will result in the cancellation of his engagement without further notice, and the next candidate in merit will be considered for the engagement.

The candidate must submit an affidavit duly attested by a Judicial Magistrate 1st Class, affirming that the engagement is on a contract basis for initially for a period of one year, or until the scheme/programme ends, whichever is earlier. The contract may be extended annually based on the candidate's satisfactory performance, approval from the competent

authority, and the availability of budget and continuation of the scheme. However, completion of the term or any point does not guarantee any extension or regularization of the engagement.
