

**Subject:- Allotment of Hostel Accommodation to the UG/PG/Interns/DNB students of Government Medical College, Srinagar in the College Hostels - Fee structure thereof.**

Upon receipt of the recommendations of the designated Committee, comprising of the following:-

3. Prof. Sheikh Imran Syed, (Warden Boys Hostel) Head of the Deptt. Physiology

5. Chief Accounts Officer, GMC, Srinagar.

to devise fresh guidelines/protocols in order to allot accommodation to the UG/PG/Interns/DNB students in the College Hostels and for smooth functioning/streamlining the allotment of Hostel accommodation to the students of the College, it is hereby ordered that:-

1. Hostel accommodation shall be made on first come first serve basis by the Hostel Wardens on the information, related to availability, received from the concerned Manager(s). However, there will be no role of Manager of the Hostel in making allotments without prior approval of the concerned Wardens.
2. The students availing Hostel accommodation shall have to pay the Hostel fee as under:-
  - a. MBBS (UG student) : Rs. 25000/- (Full course upto Final year Part II)
  - b. Internship : Rs. 10000/- (One year)
  - c. Postgraduate (MD/MS/DNB) : As per Govt. norms/policy
  - d. Postgraduate (Diploma) : As per Govt. norms/policy
  - e. UG students who join in their 2<sup>nd</sup> year after migration from other Colleges : Rs. 5000/year
3. Mess charges for 01 year to be deposited by the students in advance before availing the Hostel facility/accommodation.
4. The concerned Wardens ensure that the Hostel accommodation is allotted to the students who have completed all the pre-requisites and submit the fee receipt, as detailed at Sr. No. 02 above, to be deposited in the official Bank Accounts of the Principal/Dean, Government Medical College, Srinagar, as per the details below:-

MBBS & Interns : Principal Medical College Student Fund  
(A/C No. 0349040100007655)



Concerned Wardens shall ensure periodic checks of the records of the Hostel inmates and the amount of fee deposited by them to be conducted by the Accounts Section of the College and the Chief Accounts Officer, GMC. Sgr. shall entrust/assign the job, in this regard, to the Accounts Section of the College, in order to ensure proper scrupinization/audit of the records etc. in the Hostels, so as to avoid any sort of embezzlement of the College funds.

6. Wardens of the Hostels shall ensure strict implementation of the protocol/procedure for making allotment of Hostel Accommodation to the students.
7. The Wardens shall have to send a copy of the allotment letter along with a copy of the Bank receipt of Hostel fee, issued in favour of the students, after completion of all pre-requisites including depositing of prescribed Hostel fee, besides others to Registrar (Academics) as well as Chief Accounts Officer, GMC, Srinagar.
8. The Wardens shall obtain an undertaking from the students, being provided Hostel Accommodation, at the time of allotment to the effect that they shall remain disciplined and in case of any indiscipline/disobedience of the Hostel regulations/rules by any of the Hostel inmate, the concerned Warden shall be at liberty to withdraw the accommodation allotted to such a student(s).
9. No student(s) shall be allowed to stay in the Hostel without an allotment letter to be issued by the concerned Warden.
