Whereas; vide Government Order No. 383-JK (HME) of 2024 Dated. 20.06.2024 Criteria/Policy Guidelines for Eligibility/Selection were framed by the Administrative Department, Health and Medical Education for eligibility/selection of the tenured positions of Senior Residents/Tutor/Demonstrator in all the Government Medical Colleges; and

Whereas; after the issuance of the aforesaid guidelines, this office vide Advertisement Notice issued under No. 06 of 2026 Dated. 09-04-2026 invited applications from the eligible candidates possessing requisite qualification for filling up of tenure posts of Senior Resident/Demonstrator (In-service/not In-service doctors) in the various disciplines of Government Medical College, Srinagar; and

Whereas; in response to the aforesaid Advertisement Notice, this office has received 19 application forms in 10 departments/disciplines; and

Whereas; on scrutiny of application forms, it was found that in the following 09 disciplines/departments, the number of applications are less than or equal to the vacant positions: -

Whereas; in terms of Government Order NO. 383-JK (HME) of 2024 Dated. 20.06.2024 there is no need to conduct written tests for selection purposes in the

disciplines where the number of applications is less than or equal to the posts advertised.

Whereas, this office has received two application forms for the post of Demonstrator (Non-Medicos) in the department of Biochemistry, namely **Dr. Rumaisa Rafiq & Dr. Saniya Nissar**. However, the said Candidates are not fulfilling the eligibility criteria as per the Teachers Eligibility Qualifications framed by National Medical Commission Dated. 30th June 2025, hence their candidature is rejected.

Now, therefore, in light of the above stated position, the selection list comprising of 17 candidates in the aforesaid disciplines/departments as indicated in the Annexure "A" to this Notification is hereby notified for information of all concerned.

4. All Original Certificates for physical verification.

However, if any candidate(s) fails to report to the Office of the Registrar Academics, Government Medical College, Srinagar within the stipulated time or at the time of physical verification if the aforementioned documents are not found in accordance to the conditions laid down in the advertisement notification, his/her selection in the concerned discipline shall forfeit without any further notice.


