Subject: Engagement of the candidate for the post of Data Entry Operator.

#### **ORDER**

Pursuant to the selection list issued vide Notification No:-GMC/ICMR/MCS/35-39, Dated:- 01-05-2025, **Mr. Wasif Mustaqeem; S/o Fayaz Ahmed Bhat; R/o New Colony Batamalloo, Srinagar** is hereby engaged against the position of Data Entry Operator initially for a period of six months on consolidated remuneration of **Rs. 29,200/-** per month under ICMR funded project titled "*Identification of the clinical phenotypes and comparison of the risk factors of thiamine deficiency disorders in various regions of India: A Multicentric Study.*" at the Department of Medicine, Government Medical College, Srinagar

The said incumbent is directed to report to the Principal Investigator of the Project (Department of Medicine), Government Medical College, Srinagar for further duties subject to the following conditions:

#### **Terms and Conditions: -**

- 01) The engagee shall have to join his assignment within period of (07) days, failing which his engagement as such shall be cancelled without any further notice and the candidate falling in waiting list shall be considered for such engagement in his place.
- 02) The hired person shall be required to submit the following documents/certificates in original in the Office of Administrative Officer Govt. Medical College, Srinagar for physical verification:-
  - I. Technical Qualification Certificate.
- II. Domicile Certificate.
- III. Any other document as required under rules.
- 03) This contractual engagement is not being made against any substantive post and as such will not in any case confer any right upon the engagee to claim regular appointment or seek extension when the scheme gets over/funds get exhausted.
- 04) The contractual term of 06 months is terminable even before his term expires without any notice/citing any reason in case the performance is not satisfactory.
- 05) The engaged candidate shall have to execute an agreement that he/she will not leave the Department before the completion of 06 months contract. However, abandoning/termination of the engagement under the scheme will require one month's prior notice from the engagee, failing which the remuneration shall not be paid for one month to the incumbent which shall always remain in deposit with the Department and shall be released on completion of sanctioned term.

- 06) The engagee must work as per the job assigned under the above referred project/scheme.
- 07) If the engagee at any point in time willfully neglects or refuses to perform the assigned duties, his/her engagement shall be terminated forthwith without any notice, and he shall not be entitled to any salary for such period.
- 08) The engagee shall also submit an undertaking in the shape of an affidavit duly attested by the **1**<sup>st</sup> Class Judicial Magistrate to the effect: -
- i) That in case an adverse report about his character, Antecedent, Qualification, Date of Birth, Domicile Certificate etc. if any, is received from the competent authority to whom the references shall be made by this office, the candidate shall have no right to claim his engagement as Data Entry Operator and his engagement as such shall be deemed to have been cancelled ab-initio. He will not also claim any dues from Govt. Medical College, Srinagar as well in that case and next candidate falling in the waiting list will be considered for engagement as Data Entry Operator.
  - ii) That he has fully understood the terms, conditions and nature of his engagement under ICMR funded project titled "Identification of the clinical phenotypes and comparison of the risk factors of thiamine deficiency disorders in various regions of India: A Multicentric Study." at the Department of Medicine, Government Medical College, Srinagar and will not claim for regularization after the completion of the term or at any point of time, nor will seek extension when the scheme gets over/funds get exhausted.
