Subject: Un-authorized absence and Final Show Cause Notice Thereof.

Whereas, you have been un-authorizedly absent from your legitimate duties w.e.f. 01-03-2017 as per the report submitted by the Medical Superintendent Govt. Super Specialty Hospital Srinagar vide no. SSH/2017/874 Dated. 16-08-2017; and

Whereas, the concerned Medical Superintendent served you two notices vide Nos. Est-I/SSH/86-89 dated. 17-04-2017 and Est-I/SSH/404-07 dated. 05-06-2017 whereby you were directed to report back to duties within seven days but you failed to resume your duties within the stipulated time frame; and

Whereas, after a considerable passage of time of more than six (06) years, you have sent your joining report to the office of Principal/Dean Govt. Medical College Srinagar on 10-01-2024 ; and

Whereas, the matter was taken up with the Administrative Department vide no. AH/Est-IV/2024/8902 dated. 13-03-2024 for necessary directions/instructions; and

Whereas, the Administrative Department (H&ME) vide letter no. ME-NG/168/2024-02(E-7442887) dated. 02-04-2024 has directed this office to proceed further in the case in terms of Article 128 and 113 of JKCSR; and

Whereas, the Articles 128 and 113 of JKCSR (Volume-I) read as under:


Article 128

"Absence without leave or after the end of leave involves loss of appointment".

Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee".

Now, therefore, in view of the above facts and before proceeding further as per the directions/instructions conveyed by Administrative Department (H&ME), you are hereby directed to report before the undersigned along with statement of defense within Seven (07) days and explain why your services as Jr. Pharmacist shall not be terminated from the date of your unauthorized absence, failing which it shall be presumed that you have nothing to say in your defense and action as warranted under above quoted Articles of JKCSR shall be initiated without any further notice.
