## **Notification**

Whereas, Tutor/ Clinical Instructors of Govt. B.Sc Nursing College (Govt. Medical College Srinagar) have been frequently submitting applications/ representations for their placement to the next higher category of Sister Tutor as per executive order issued by the Government vide order No. 456 JK (HME) of 2023 dated 02-06-2023.

Whereas, the applicants were appointed against the posts of Govt. Nursing College Srinagar on the recommendations of J&K Service Selection Board vide No: SSB/Sell/Secy/013/1271-74 dated 11-03-2013 conveyed to this office by Administrative department vide No: ME-NG/31/2013 dated 02-04-2013 and there service are being utilized in the College of Nursing since their appointment.

Whereas, the posts on which the applicants /officials are representing are sanctioned in Govt. AMT School Srinagar and are lying vacant as on date, however, the seniority lists are framed separately for both the institutions despite having similar nature of work and assignment in both the teaching institutions vide No: AH-09/Est-II/MC/202/6136-37 dated 09-12-2021 for Govt. B.Sc Nursing College and vide No: AH-09/Est-III/MC/2024/7036-39 dated 30-01-2021 for Govt. AMT School Srinagar.

Whereas, after placing the case before the departmental Establishment Committee it was decided that the seniority lists have already been framed separately for both the institutions well before at the departmental level which needs to be merged again so that the officials shall be considered for placement as Sister Tutors against the posts of Govt. AMT School Srinagar.

Whereas, in view of above circumstances and conditions, since there being the same and similar job profile and work culture in both the institutions it has been felt imperative by the department to unite and merge the seniority lists of both the colleges and institutions only after inviting objections from the concerned members of both the institution owing to the reasons that the recruitment rules have been issued under single unit (Nursing Education Unit) in terms of executive order in vogue.

Now therefore, in view of the above facts and circumstances, the tentative seniority list of Sr. Sister Tutor(s), Sister Tutor(s) and Tutors/ Clinical Instructors of Govt. B.Sc Nursing College Srinagar and Govt. AMT School Srinagar (Govt. Medical College Srinagar) is prepared as per the service Bio data and is issued as "Annexure A" for information of all the concerned members of the units for inviting objections within a period of 15 days from the date of issuance of this notification. Any representation(s) received after stipulated date shall not be entertained.

**Subject:** Application of Tutor / Clinical Instructors of Govt. B.sc Nursing College for promotion against the posts of Govt. AMT School Srinagar & furnishing of views / comments thereof.

Sir,

Kindly refer your letter no GMCS/HS-096/5792-96 dated:23/01/2025 for the subject cited above. In this connection it is to inform your goodself that the posts of sister tutors belong to AMT School Srinagar and time again it was requested that the posts may kindly be filled up vide letter No,s:AMTS/2024/1239 dated:01-12-2024, No-AMTS/2024/995 dated:15-10-2024, No- AMTS/1917 dated:06-03-2024, No-AMTS/2023/1212 dated: 22-11-2023. So that the teaching programme of this institution could be taken up smoothly but till date no action seems to have been taken, In case these posts are utilized for promotion by the tutors from College of Nursing, this institution would face irreparable loss and the same shall remain held up by the said employees / Tutors till their eligibility for the next higher promotion.

AMT School caters the needs of following stream with annual intake capacity as:  
General Nursing 3 Years course – 128, General Nursing (LE) 2 Years course- 32, Medical Assistant – 2 Years course – 40, Laboratories Assistant – 2 Years course – 40, Dental Assistant – 2 Years course – 40, Sanitary Inspector – 2 Years course – 40, X-ray Assistant – 2 Years course – 40, Anaesthesia Tech. – 2 Years course – 40, Operation theatre tech. – 2 Years course – 40, ECG Tech. – 2 Years course – 40, Dialysis Tech. – 2 Years course – 20, ISM (Pharmacist) – 2 Years course – 20 = **Total Intake Capacity = 520 Per year**

Imparting skilled based quality education is not possible without their own teaching staff, besides these institutions AMT School & College of Nursing have their separate identity therefore mingling/bracketing of the seniority would adversely affect these institutions which would create numerous problems for both the institutions. It is pertinent to mention here that INC (Indian Nursing Council) has also derecognized AMT School for want of requisite teaching faculty etc.

It is therefore requested that necessary action in this matter may kindly be taken accordingly and with reference to the standing instructions provided under rules.
