It is hereby notified for information of all those candidates who have applied for engagement as **Data Entry Operator** in response to **Advertisement Notice No. Micro/HOD/2026/1182-89, Dated: 30.01.2026** under National One Health Programme for Prevention and Control of Zoonosis in the Department of Microbiology GMC, Srinagar that their written test (OMR MCQ based) shall be conducted in the **Anatomy Main Lecture Hall of Government Medical College, Srinagar on 19.05.2026 (Tuesday) from 02:00 PM to 03:00 PM.**

**In this context, the applicants who are appearing in the examination are advised to strictly adhere the following instructions:**

01. The Admit cards/Roll number slips of the candidates shall be available w.e.f. **12.05.2026** in their respective Registered User Accounts through which they have applied for the above posts.
02. On the actual date of the examination i.e., **19.05.2026 (Tuesday)**, the candidates shall report at the examination centre **60 minutes prior to the scheduled commencement of examination** for verification of their identity along with their admit cards (coloured format only) and anyone of the following documents as proof of their identity: -
  - a. Photo Identity card issued by the competent authority.
  - b. Driving license.
  - c. Pan card/Adhaar card.
03. Candidates must not bring any prohibited item to the examination centre.
04. The candidates are advised to bring **blue/black ball pen** only, in order to mark an answer on their OMR sheets.
05. Any type of electronic devices, mobile phones, Bluetooth devices, scanning devices, earphones, tablets, books, note books, calculators, smart watches, laptop, I-pad etc. are not allowed inside the venue. Violation, if any, shall strictly be dealt under law.

06. Scratching, overwriting, tick-marks and multiple answers shall be considered as wrong.
07. Do not make any unnecessary/stray marks on the OMR sheet.
08. Use of whitener, eraser, nails, rubber, blade on the OMR sheet is completely prohibited.
09. Any attempt to seek or provide assistance during the examination will lead to immediate disqualification and expulsion from the examination centre.
10. The instructions on the question booklet and OMR sheet should be followed in letter & spirit.
11. Issuance of the admit card is provisional and does not imply confirmation of eligibility or selection. The candidature is subject to verification of eligibility criteria as per the information provided in the application form. If, it is found at any stage that the candidate does not fulfil the eligibility criteria/parameters/ requirements, his/her candidature shall be cancelled without prior notice.
