However, Medical Superintendent of concerned Hospital shall provide a Unique ID Code to these interns. The interns shall return this unique ID code to the concerned HOD / Medical Superintendent after completion of training.
- ❖ The student shall be provided with a certificate of internship signed by concerned Medical Superintendent and countersigned by Head of Department concerned and by Dy Registrar Academics as the case may be.
- ❖ Fee of Rs- 5000/- per intern shall be paid as applicable vide GO No: 197 - HME of 2009, Dated: - 05/05/2009, from all Institutions. The fee so deposited shall be maintained by the office of the Financial Advisor / Chief Accounts Officer (CAO)GMC Srinagar.
- ❖ That the posting in the sensitive areas shall be regulated by concerned Medical Superintendent in consultation with HOD concerned.
