- 1. Before joining the Department, the selected candidate shall submit an affidavit in the office of the Senior Resident Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate to the effect that:
 - a. he will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeded on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - b. he shall remain disciplined during the tenure period, any kind of misconduct make his liable for termination without any prior notice.
 - c. he is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against his.
 - d. he shall not claim any experience certificate in case he leaves before completion of first year.

e. he will not indulge himself in any private practice. In case he is found doing private practice his appointment shall be terminated without any notice.
