WHEREAS; vide this office No: GS-MC/L-Sur/319-323 dated: 23.05.2023, you were asked to resume your duties within a period of three days and explain your position for remaining unauthorizedly absent w.e.f 08.05.2023 and your reply should reach to the office of the undersigned through HOD concerned with his definite remarks;


WHEREAS; instead of resuming your duties, you have submitted reply which clearly indicates that you have left the country to pursue two months fellowship in China without permission of the competent authority.

WHEREAS; it was already intimated to you through concerned HOD that you are not eligible to pursue two months fellowship in China in terms of Rule 61(4) (i) of the Jammu and Kashmir Civil Services (Leave) Rules, 1979 notified vide S.O 234 of 2020 dated: 21.07.2020 and instructions issued by the General Administration Department vide: Circular No. 49-JK(GAD) of 2022 Dated. 07-12-2022, as you have not completed mandatory service of five years as yet;

WHEREAS; leaving station/country without prior permission of the competent authority amounts to gross misconduct and entails disciplinary action even involves loss of appointment in terms of Article 128 of J & K CSRs for absence from duty without leave or after the end of leave;

Now, therefore, in light of above, you are hereby provided **last and final opportunity** to resume your duties forthwith and explain your position for leaving the station/country without permission of the competent authority, failing which it shall be presumed that you have nothing to say in your defence and necessary recommendations for initiation of disciplinary action against you as warranted under rules shall be made to the Government (H&ME);

Your reply in this behalf should reach to the Office of the undersigned through HOD concerned with his definite remarks.
