Same needs to be submitted strictly in accordance with the criteria in respect of age, qualification and intake capacity allotted by Administrative Department of Health and Medical Education of Jammu and Kashmir from time to time.

The notification regarding the registration fee to be deposited as under relevant rules shall be issued separately.

Note: -

- 1) The Registration forms shall be submitted in the office of SAHC - JK GMC Srinagar for Kashmir Division and in the office of SAHC - JK GMC Jammu for Jammu Division by or before cutoff date.
- 2) The Registration forms shall be submitted after proper verification and tallying of All Academic Documents with the Original Documents and Selection List (BOPEE) and Left Over Seats of each candidate.
- 3) If at any stage, it is found that the student /candidate has submitted forged documents, the admission of the candidate shall be cancelled.
