Subject:- Appointment of candidates as "Junior Grade Nurses" in Government Medical College and Its Associated Hospitals Srinagar, advertised vide JKSSB Notification No. 02 of 2021 dated 26-03-2021.

On the basis of recommendations made by J&K Service Selection Board vide their communication No's:-JKSSB/Sel/Secy/2022-23/357-61 dated:-28-02-2023 and JKSSB-ADM/41/2023(7184697), conveyed to this office by the Health and Medical Education Department, J&K vide No's ME-NG/126/2023-02 Dated:-03-04-2023 and ME-NG/126/2023-02 dated 30-05-2023 and consequent upon receipt of satisfactory CID reports from Criminal Investigation Department, J&K, sanction is hereby accorded to the temporary appointment of **sixteen (16)** candidates as "**Junior Grade Nurse(s)**" in the pay Level-4 (25500-81100) in Government Medical College & Its Associated Hospitals Srinagar forming "**Annexure X**" to this order.

The appointee(s) shall report to the office of Principal/ Dean Govt. Medical College Srinagar within a period of twenty one (21) days from the date of issuance of this order; failing which they shall forego their right to appointment, and the same shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointee(s) shall be allowed to join only on the production of following certificates (In original) to be verified subsequently by the respective Drawing and Disbursing Officer(s):

- I. Date of Birth certificate.
- II. Qualification certificates.
- III. Domicile certificate.
- IV. Medical Fitness certificate from Chief Medical Officer (CMO) concerned.
- V. No Objection Certificate (NOC) from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Department, he/she shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self employment unit/ enterprise before joining the Government service. He/she shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit enterprise and recovery to be made and also personally monitor its recovery.
- VI. Relevant category certificate, wherever applicable.
- VII. Any other document(s) as required under rules.

The appointment of the above candidates shall further be subject to the following terms and conditions:-

1. The salary of the appointee(s) shall not be drawn and disbursed to them unless and until, satisfactory reports in respect of genuineness of qualification/Date of Birth/ relevant category certificate (if any), is received from the concerned authorities/ agency.
2. The appointment of the candidate(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 Dated:- 24.12.2009.
3. The appointees shall be on probation for a period of two (02) years.
4. The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.
5. The appointment in Divisional Cadre is non transferable from one Division to another or from one Medical College to another.
6. The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
7. The inter-seniority of the above appointee shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Service Selection Board.
8. The appointee(s) shall give an undertaking in the shape of an affidavit duly attested by Ist Class Judicial Magistrate to the effect that if on verification, their qualification/ date of Birth/ reserved category certificates from the concerned issuing authorities are found fake/forged, their appointment as *Junior Grade Nurse(s)* in Govt. Medical College and Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against them. He/She in that case will not claim for any dues from Govt. Medical College Srinagar.


