TERMS AND CONDITIONS -TECHNICAL REQUIREMENTS

01. Requirements

Sealed applications affixed with ₹5/= revenue stamps are invited for and on behalf of the Governor of Jammu and Kashmir UT through the Principal/Dean GMC, Srinagar from the reputed publishers/their authorized agents for empanelling the firms with Central library GMC Srinagar for the supply of Print/online only for the calendar year 2027.

02. Sale of documents

The detailed document along with the terms and conditions/ technical requirements etc. can be had from the Office of Chief Librarian or can be downloaded from GMC, Srinagar website www.gmcs.ac.in from 01/07/2026 to 21/07/2026 against a non-refundable application cost of ₹1000/= payable in the shape of Bank Draft pledged to the Chief Accounts Officer, GMC Srinagar well within the stipulated date of sale of document.

03. Submission of documents

Application along with EMD as per clause No. 09 and supporting documents shall be contained in an envelope duly sealed and super scribed with Emp. No. and Date should reach the office of Principal/Dean, GMC, Srinagar on or before 28/07/2026. Application can be sent by registered post or courier. However, the timely delivery of the application must be ensured by the vendors. The College shall not be responsible for any postal delay. Applications received after the stipulated date shall be rejected.

04. Documents to be included

The following documents must be enclosed with the applications failing which the applications shall be rejected: -

- A. Latest copy of the Income Tax/Sales Tax Clearance Certificate.
- B. Details of the Medical Institutes /Medical College where the journals are being supplied by the applicants. (Minimum 03 Government Institutions)
- C. Registration Certificate.
- D. Membership Certificate.
- E. **Publisher's Exclusive Distributor Certificate.**
- F. EMD for ₹ 50,000/=
- G. Application Fee ₹ 1000/=

05. ONOS (One Nation One Subscription)

The Union Cabinet had approved One Nation One Subscription scheme to provide country-wide access to international high impact scholarly research articles and journal publications to students, faculty and researchers of all Higher Education Institutions managed by the Central Government and State Governments and Research & Development Institutions of the Central Government.

Government Medical College, Srinagar is covered under the ONOS Scheme, the Journal Titles recommended by HOD's other than covered under ONOS Scheme will be subscribed.

06. Opening of Applications

Applications shall be opened by set committee on 30th July 2026 or any other subsequent date convenient to the College authorities in presence of the applicants or their authorized representatives who may wish to be present at that time.

07. Agreement

The successful firms shall have to execute a formal agreement with the Lt. Governor of Jammu and Kashmir state through the Principal/Dean GMC Srinagar on a non-judicial stamp paper of ₹100/= Value within a period of 30 days from the date of the communication of the acceptance of their applications. All expenses on account of Stamps, Registration and other related charges there to shall be borne by the successful firms. Non-execution of agreement shall not however, prevent the department from taking action against the successful applicants under law in force at that time.

08. Right Reserved by the Government

The Principal/Dean, GMC Srinagar reserves the right to accept or reject any Application or part thereof without assigning any reasons.

09. Earnest Money

The application must be accompanied with Earnest money in the shape of CDR for ₹ 50,000/= drawn on any Nationalized Bank pledged in favour of the "Chief Accounts Officer, GMC Srinagar" for the fulfilment of the contract. The EMD will not carry any interest on it. The EMD of unsuccessful applicant will be refunded in full on receipt of request from the firm after the finalization of the empanelment process. Application without Earnest money shall be rejected by the Institute. The EMD of successful Firm will be released in their favour on the successful completion of the contract period.

10. Payments

Online Journal Titles: Payment for the Online Journal titles shall be released on a deferred basis. The successful firm shall ensure activation and uninterrupted access to the subscribed online Journals within 30 days from the date of issuance of order.

Print, Print and Online Journal Titles: Deferred Payment will be released on the basis of supplies received.

Payment is subject to the condition that successful firm(s) shall produce following documents:

1. Activation/Subscription Confirmation from Publisher.
2. 100% Remittance Proofs.
3. Bank conversion certificate
4. Agreement copy
5. Publishers price proof

The approved firm upon receipt of confirmed order shall process institutional subscription and make payment for titles to respective publishers on behalf of GMC, Srinagar. The firm shall submit their invoices within **30 days** from the date of issuance of subscription order along with all above mentioned documents.

The subscription shall include perpetual access rights to all Online Journals purchased during the current subscription year.

11. Adjustment and Reconciliation of Payments

Payment shall be adjusted with reference to the cost of journals as per publisher's price list, received invoices and successful completion of subscriptions.

12. Placing Orders

Orders for supply of Journals will be placed with the successful approved panel depending on the fulfilment of technical requirements/Terms and Conditions. Only those firms will be empanelled who will qualify all the technical requirements and will fulfil terms and conditions of the empanelment document. The successful firm administratively approved will be eligible for receiving the supply orders from GMC, Srinagar after negotiations with the firm regarding services/**Discount offers**.

13. Subscription ID's

The supplier shall submit publisher's registration ID's of the journals as well as provide technical support to enable online access to journals.

14. Online Activation

The online access to journals which are available free along with print subscription should be provided by the agent/vendor without charging any additional amount. Online access needs to be activated on all Institutional IP's within one month from the issuance of supply order.

15. Contract Period

The contract period for subscription of the Medical journals will be one calendar year 2027 or as per the publisher's policy of completion of volume/issue per journal title. Supply of Journals should commence from the issue No.1 of the volume starting during the year.

Successful panel of suppliers/vendors will remain empanelled with Government Medical College, Srinagar for a period of one calendar year i.e. 2027. However, the department reserves the right to remove any supplier from the empanelled list if the service provided by the supplier is found to be unsatisfactory or if the information provided for empanelment is proved to be false.

16. Delivery of Journals

The Agent /vendor shall procure all the journal subscribed by the Government Medical College, Srinagar from the respective publishers within 30 days by freight arrangement to the GMC, Srinagar and supply the same to library with 100% assured deliveries through top logistic companies. The agent/vendor will ensure safe delivery of journals to the Central Library along with the challan /delivery proof in duplicate. One copy of the challan delivery proof will be returned back by GMC, Srinagar as a

proof of receipt. It will be essential for the party to obtain acknowledgment from Central library, GMC Srinagar as a proof of supply. Each supplied journal should bear the mark and stamp of the original foreign publisher/Exclusive agent(s) in India.

17. Penalties

In the event of the supplier failing, declining (without assigning any valid reason) or in the event of any damage occurring or being caused by supplier, the Government shall without prejudice to any other remedy available to it under the law for the time being in force in J&K:

- a Recover the amount of loss caused by damage, failure or default
(Including the Consequential damages).
- b Impose a penalty up to 10% of the proportionate value of the order.
- c The delay in the supply and imposition or penalty shall be subject to "Force Majeure" and "Arbitration" Clauses of the contract.

18. Missing Issues-Delay in Supply

The supplier shall monitor claims for missing issues of journals, if any and arrange to provide replacement. The firm shall have to accept full responsibility in case where no issues or substantial number of issues are not supplied to the library for which order has been placed.

The firm shall communicate along with documentary proof to GMC, Srinagar for the delay e.g. publication not done or delay in printing on part of the publisher or the publication running behind the schedule. The firm will be liable to refund the subscription amount along with the interest @5% if it fails to supply missing issues within the target period of 2 months.

19. Sub-letting of the Contract

The successful applicant shall be responsible for full execution of the contract and shall not in any case assign or sublet ordered journals or part thereof to any other party which will otherwise attract penalty of 10% of the total value of the order by forfeiting Bank guarantee and even debarring and black listing of the successful applicants.

20. Force Majeure

Any failure or omission to carry out provision of this order shall not give rise to any claim by the department and the supplier one against other if such failure or omission arises from an act of God which shall include all acts of natural calamities such as fire, floods, earthquakes, hurricane or any pestilence's or from civil strikes compliance with any statute or regulations, riots, lockouts and embargoes or from any political or any other reasons beyond the control of the parties including war (whether declared or not) civil war or a state of insurrection.

21. Arbitration

If at any time, any question difference or dispute whatsoever arises between two parties hereto or in relation to a part thereof, either of the party may give to other notice in writing of the existence of such a question or dispute or difference and same shall be referred for award to two arbitrators, one to be nominated by the College and the other by the supplier, or in case of such arbitration, not agreeing then the award or an "umpire" appointed by the arbitrator in writing before proceeding with the case. The decision of the arbitrators/Umpires shall be final and binding on the parties.

The provision of J&K Arbitration Act 2002 and of the rules there-under and any statutory modification thereof shall be deemed to apply to arbitration. Either party shall serve such notice of existence of any question, dispute or difference in connection with the contract within 30 days of the beginning of such disputes, failing which all rights or claims under this contract shall be deemed to have been forfeited and absolutely barred.

Upon every of any such reference the cost and incidentals to the reference and award respectively shall be at discretion of the Arbitrators/umpires appointed by them who may determine the amount there of or direct the same to be fixed as between solicitor and client or as between parties and shall direct by whom to whom and in what manner the same shall be borne and paid. The supply to be executed under the contract shall if reasonably possible, continue during arbitration proceeding and no payment due from or payable by the government shall be withheld because of such proceedings except to the extent which may be in dispute. Jurisdiction for all arbitration cases or legal cases shall be under the jurisdiction of Srinagar (J&K) Courts only.
