On the basis of recommendation made by J&K Service selection Board vide their communication no : SSB/Sel/Secy/ /2022-23/362-66 dated: 28-02-2023 conveyed to this office by Health and Medical Education Department J&K vide No: ME-NG/129/2023-02 Dated: 06-04-2023 and consequent upon receipt of satisfactory report from Crime Investigation Department J&K, Sanction is hereby accorded to the temporary appointment of the following candidate as Junior Occupational Therapist in the pay level-6(35400-112400) in Govt. Medical College Srinagar and Its Associated Hospitals Srinagar.

The appointee shall report to the office of Principal/Dean Govt. Medical College Srinagar **within a period of 21 days** from the date of issuance of this order; failing which he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.


The appointee shall be allowed to join only on the production of following certificates in original to be verified subsequently:

- Date of Birth Certificate.
- Qualification Certificate.
- Domicile Certificate.
- Medical Fitness Certificate from Chief Medical Officer (CMO) concerned.
- No Objection Certificate from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Department, he shall relinquish the proprietorship of Unit/Enterprise and also stakes if any in such self employment unit/enterprise before joining the Government Service. He shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of Proprietorship and stakes , if any, in such self employment unit Enterprise and recovery to be made and also personally monitor its recovery.
- Relevant category certificate, wherever applicable.
- Any other document as required under rules.



The appointment of the above candidate shall further be subject to the following conditions:-

1. The salary of the appointee shall not be drawn and disbursed to him unless and until, satisfactory reports in respect of genuineness of qualification/Date of Birth/relevant category (if any) are received from the concerned authorities/agency.
2. The appointment of the candidate shall be governed by the New Pension Scheme as notified vide SRO-400 dated: 24-12-2009
3. The appointee shall be on probation for a period of two years.
4. The interim arrangement, if any, made against the above post shall be deemed to have been terminated forthwith.
5. The appointment in Divisional Cadre is non transferable from one Division to another or from one Medical College to another.
6. The appointment of the above appointees shall be subject to outcome of writ petitions, if any, pending on subject in any court of competent jurisdiction.
7. The inter-seniority of the above appointee shall be as per the merit secured by him in the selection process as indicated against him in the selection list furnished by J&K Service Selection Board.
8. The appointee shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that if on verification, his qualification/date of birth/reserved category certificate (s) from the concerned issuing authorities are found fake/forged, his appointment as **Junior Occupational Therapist** in Govt. Medical College and Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him. He/She in that case will not claim for any dues from Govt. Medical College Srinagar.
