Applications through online mode are invited from the eligible applicants who are domiciled in the Union Territory of Jammu and Kashmir and possessing the prescribed Academic/Professional qualification and age for the tenure post of Senior Residents/Demonstrator/Tutor in the disciplines as enumerated at Table "A". "Those candidates who are not in-service shall be engaged under S.O. 364 of 2020 Dated. 27-11-2020 (Academic Arrangement basis), whereas application forms of the in-service eligible candidates shall be entertained only after fulfillment of all pre-requisites, in accordance with the relevant rules, as envisaged in the J&K Civil Service Rules 1979 and production of NOC from the parent department as envisaged in the Circular No. 03-HME of 2019 Dated. 27.05.2019. The selected candidates shall be engaged initially for a period of one year which is extendable upto maximum of three years, however, further extension shall be granted subject to better performance of the candidates to be certified by the concerned HODs after completion of each year of their engagement: -

# **IMPORTANT INSTRUCTIONS FOR CANDIDATES: -**

- a) Candidates are advised to go through the instructions and all the eligibility conditions prescribed for the post before filling in the online application form.
- b) Link for filling up online application form for the above position shall be available on the official website of Government Medical College, Srinagar i.e. https://www.gmcs.ac.in/ w.e.f. 01.08.2025 from 10:00AM onwards to 16.08.2025 upto 4:00PM. No other means/mode of application shall be accepted.
- c) Candidates are required to sign up before filling in the application form.
- d) After logging into the account, candidates are required to fill in all the requisite fields of One Time Registration (OTR) i.e. personal information, contact information & educational Qualifications, service details and uploading documents etc.
- e) Candidates are required to upload scanned copies of original certificates/ affidavit(s). Photocopies of certificate/affidavit(s) uploaded shall not be entertained. Size of Certificate/affidavit must be less than or equal to 1024KB in PDF format only.
- f) The candidate shall also be required to upload images of recent photograph, signature and thumb impression. Size of photograph (passport size) and signature/Thumb must be less than or equal to 700KB in \*.jpeg or \*.jpg only.
- g) The candidate must write his/her name, parentage and date of birth strictly as per the matriculation certificate.
- h) Candidates are advised in their own interest to submit online applications much before the closing date and not to wait till the last date to avoid the possibility of disconnection/ inability or failure to login to the online application portal on account of heavy load on the website during the closing days.

### Terms & Conditions: -

- Pursuant to Government Order No. 383-JK (HME) of 2024 Dated. 20-06-2024, the Eligibility criteria has been fixed as per Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022 issued vide Notification dated. 14-02-2022.
- The selection of the candidates shall be made on the basis of the performance in MCQ based Written Test only as prescribed vide <u>Government Order No.</u> 383-JK (HME) of 2024 Dated. 20-06-2024.
- **3.** Incomplete application form(s) in any respect or not having relevant certificates/documents/Affidavit/Fee receipt attached therewith shall not be accepted.
- 4. Conditions for In-service/ Not In-Service Candidates: -

### For in-service candidates: -

- The In-service doctor shall be paid salary as per their LPC.
- Applicants working in Director of Health Services, Kashmir/Jammu are required to submit their application forms along with No Objection



Certificate from their parent Department without which their application forms shall not be entertained as envisaged in Circular No. 03-HME of 2019 Dated. 27.05.2019.

### For (not in-service) Academic Arrangement Basis Candidates: -

- Not In-service doctors shall be paid stipend in accordance with S.O. 364 of 2020 Dated, 27-11-2020.
- **5.** The candidates shall have to submit their application forms accompanied with the self-attested copies of the following documents: -
  - MBBS marks sheet of all phases and qualification certificate.
  - b. MD/MS/DNB/MCh./DM qualification/degree certificate of the respective specialty in respect of medical candidates.
  - c. M.Sc Medical Biochemistry qualification/degree certificate in the case of non-medical candidates.
  - d. Ph.D Medical Biochemistry qualification/degree/Marks certificate in the case of non-medical candidates.
  - e. Internship certificate.
  - f. Date of Birth Certificate.
  - g. NMC/Jammu and Kashmir Medical Council Registration Certificate.
  - n. Domicile Certificate.
  - i. No Objection Certificate (for In-Service candidates only)
  - j. Experience certificate (only for those candidates who have already done Registrarship/Senior Residency/Demonstratorship/Tutor)
  - k. Affidavit(s).
  - Dated. 20-06-2024, the maximum tenure of Senior Residency/Tutor is three years. Any candidate having already done three years Registrarship/ Senior Residency/Demonstratorship/Tutor shall not be eligible to apply against the notified positions. However, if any candidate has done Senior Registrarship/Senior Residency/Demonstratorship/Tutor upto 30 months, he/she can apply to do the remaining Senior Residency period so as to complete three years term.
  - 7. The candidates shall have to submit an Affidavit duly attested by the Judicial Magistrate to the effect that: -

- he/she has not done Registrarship/Demonstratorship/Senior Residency earlier within or outside J&K Union Territory. (Only for those candidates Who are applying a fresh)
- he/she has done \_\_\_\_\_ months of Residency/Demonstratorship/Tutor in the \_\_\_\_ institution/medical college. (only for those candidates who have already done 30 or less than 30 months of Residency/Demonstratorship/Tutor)
- The information submitted in the application forms is true and correct and nothing has been concealed therein.
- **8.** Those doctors who have already completed their tenure as Registrar/Demonstrator/ Senior Resident/Tutor in the discipline applying, cannot apply and their application forms shall not be considered.
- **9.** A separate application form is to be filled up for each post/specialty and fee is to be deposited separately for each post applied for by the candidate.
- 10. The upper age-limit for appointments as a Senior Resident in broad specialties shall be forty-five years: Provided that for the subjects of Anatomy, Biochemistry, Physiology, Pharmacology, Microbiology, Pathology, Forensic Medicine and Community Medicine, the upper age-limit shall be fifty years as on cutoff date of advertisement for both in-service and not in-service candidates.
- 11. In case any declaration made by the candidate, is found false or if the candidate has willfully suppressed any material/information relevant to his/her appointment, his/her selection will be cancelled ab-intio and he/she shall be liable for action as warranted under rules.
- **12.** There shall be a waiting list which shall remain in force for a period of **three months** from the date of issue of the selection list.
- **13.** In terms of S.O. 364 of 2020 Dated. 27-11-2020, the appointment on Academic Arrangement Basis of the appointee shall be terminable on either side by serving a prior notice of one month or on payment of one month's salary by the appointing authority.
- **14.** In case of a tie in merit secured by two or more candidates in the written test, the candidate(s) older in age shall be given preference.

**15.** No selected Candidate who joins the Institution as Senior Resident shall be given Experience Certificate, if he/she fails to serve on such post/ position for at least six months.
