 - a. He will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeds on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - b. He shall remain disciplined during the whole tenure; any kind of misconduct shall make him liable for termination without any prior notice.
 - c. He is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
 - d. He shall not claim any experience certificate, in case he leaves Senior Residency before completion at least of six months.
 - e. He will not indulge in any private practice. In case he is found doing private practice his appointment shall be liable for termination without any notice.
