

**Subject:-Grant of Promotion to the post of Senior Grade Nurse from the date of its retrospective effect in favour of Mrs. Ameena Akhter- Govt. SMHS Hospital.**

Whereas, among others Mrs. Ameena Akhter was appointed as Jr. Grade Nurse vide Order No. 163 of 1987 dated: 19-08-1987 issued under endorsement No. MCH/Est-II/1862-1947 dated 19-08-1987 and was figuring at serial No. 24 in the said order/list; and

Whereas, in terms of order No. AH-9/Est-II/1008-11 dated. 15-05-1993 the official was adjusted against the post of Senior Grade Nurse in her own pay & grade with charge allowance as admissible under rules with effect from 11-03-1993; and

Whereas, the official remained unauthorisedly absent from her duties for the following spells:-

- a) 03-01-2002 to 04-06-2002,
- b) 28-07-2002 to 11-09-2005.

Whereas, in terms of order No. 573 of 2014 dated 06-12-2014 issued under dispatch No. AH/Est-II/903 dated 06-12-2014, the period of unauthorized absence reflected above was treated as "Dies-Non" in terms of Article 163 of CSR Vol-I read with SRO. 514 Dated: 22-11-1999; and

Whereas, vide order No. 17 of 2016 dated 06-04-2016, the officiating arrangement as Sr. Grade Nurse issued in her favour vide order No. AH-9/Est-II/1008-11 dated. 15-05-1993 was confirmed with effect from 08-06-2015, without taking into consideration the period from 12-09-2005 to 07-06-2015, for which the official has been representing/approaching time and again; and

Whereas, the Departmental Promotion Committee meeting held in the year 2018 had opined to re-examine the case thoroughly and put in the next DPC for consideration; and

Whereas, the case was thoroughly examined by the office and placed before the Departmental Promotion Committee held on 20-05-2022.

Whereas, while taking into account the full background details of the case, the Departmental Promotion Committee passed the following decision:-

***"The case was thoroughly deliberated in the committee in light of the full background details after considering the import of the Dies Non for a period of 3 years and 17 days and the official figures in the seniority list of Junior Grade Nurse on 26-08-1990 between the officials namely Shameema Gh. Mohd (S No. 183) and Jawhara Akhter (S***

No. 184) issued vide order No. 469 of 2010 dated 07-01-2010. Since the junior counterpart of the official namely Jawhara Akhtar has been promoted as Senior Grade Nurse with effect from 30-03-2011, and it was decided to grant retrospective effect to the official with effect from 30-03-2011 notionally against the available post of Senior Grade Nurse on the newly created post at Govt. SMHS Hospital Srinagar created vide order No. 223 of 2010 dated 03-04-2010 without any consequential monetary benefits."
