Whereas, vide this office Notification No. AH/GMC/22/2577-79, Dated: 30.07.2024, the solved Question Papers of these tests as per respective Answer Keys framed by the paper-setters were notified for information of all concerned candidates with a provision that if any candidate feels that the key to any question(s) is/are wrong, he/she can submit objection/representation on the prescribed format within two days i.e upto 01.08.2024( 04.00 PM) alongwith a sufficient documentary proof/evidence and fee of Rs. 300/-; and

Whereas, two candidates have sent emails whereby they have sought waiver of fee and change in the procedure for receipt of representations; and

Whereas, the procedure adopted by this institution for receipt of objections/representations is a standard practice being followed by almost all the reputed organization/agencies involved in the conduct of competitive examinations like NTA, JKPSC, JKBOPEE etc. The fee charged is refundable in case of genuine/correct representation and is being levied only to check the frivolous and non-serious representations; and
