**Subject:- Unauthorised absence and Show Cause Notice thereof.**

Whereas, Medical Superintendent Govt. Lalla Ded Hospital Srinagar vide communication No. LHD/Est-II/542 dated 09-06-2023 had reported that you have initially applied for 30 days earned leave with effect from 01-09-2021 which was sanctioned vide order No. LDH/Est-II/1071-1073 dated 17-09-2021.


Whereas, you were supposed to join on 01-10-2021 but have failed to resume your legitimate duties on the stipulated date and continued to remain on unauthorised absence without any intimation to the immediate controlling officer/superiors without submitting any leave application form for extension of leave.

Whereas, you were served upon duo notices by the concerned Medical Superintendent on 25-01-2023 and 12-04-2023 on your residential address and was also published in two leading daily newspapers of Kashmir division too, for seeking reply regarding your unauthorised absence from the legitimate duties.

Whereas, you did not bother to attend upon the instructions embodied in the correspondences presumably by appearing in person before the concerned Medical Superintendent or could furnish the reply to the notices served upon till date and it seems that you are not interested to resume your legitimate duties.

Now, therefore, before your appointment as Junior Grade Nurse is terminated, you are hereby directed to explain your position as to why the action contemplated is not taken against you, you should personally attend this office with your reply routed through concerned Medical Superintendent **by or before 20<sup>th</sup> August 2023** on any working day.

In case of your failure to report this office along with your reply, it shall be presumed that you have nothing to say in your defence and your appointment shall be terminated with effect from the date of your absence without further notice in terms of **Article 128 of JKCSR 1956.**
