Whereas, various representations from the members of the unit along with allied documents were received by this office wherein the following issues have been raised:-

- (a) Medical Superintendnet Govt. SMHS Hospital Srinagar vide communication No. Est-II/SMHS/2481 dated 02-07-2024 has forwarded the representation of Mr. Zahoor Ahmad Beigh, Head Assistant wherein the official has requested for placing his name in the seniority list as per the serial and status reflected in the OPG order issued vide order No. 303 AH of 2021 dated 02-07-2021.
- (b) Principal AMT School Srinagar vide communication No. AMTS/2024/934 dated 05-07-2024 has forwarded the representation of Mrs. Ruhana Qamar, Sr. Assistant, wherein the official has stated that some undue promotions have been accorded to the officials who were actually junior to her as far as their appointment(s) is/are concerned and has requested to examine the case in detail and settle her seniority position accordingly.
- (c) Another representation received vide receipt No. 1223 dated 15-07-2024 from various Junior Assistants working in different sections of the institute wherein they have stated that some junior Assistants have qualified departmental examination have been promoted and placed in the category of Senior Assistants and are figuring over and above to these officials in the tentative seniority list despite being junior to them by virtue of their appointments/ promotions, which may be examined and verified. Besides, they have also stated that some of the Junior Assistants who have not qualified the departmental examination have previously been promoted as Sr. Assistants. As such have desired that similar policy and treatment be adopted by the department in their favour and may be promoted as Sr. Assistants as well without passing the departmental examination.
- (d) Another, representation received from Mrs. Firdousa AKhter, Sr. Assistant, Govt. Medical College Srinagar with the statement that some officials figuring below her in the seniority list issued from time to time have been removed from the seniority list of ministerial unit have been placed in the Store unit by way of OPG promotion in the store unit, as such has requested for her placement in the store line as well.

Whereas, the above issues have been examined with reference to relevant records and standing rule position have been redressed as under:-

- (a) That Mrs. Sujata Jalali and Mr. Zahoor Ahmad Beigh, Head Assistants were figuring at serial No. 07 and 08 respectively, and Mrs. Kudsiya, Mrs. Rukhsana Jabeen, Mrs. Tasleema Sultan and Mr. Gh. Hassan Bhat, Head Assistants/ Cashiers were figuring at serial No. 02, 03, 05 and 06 respectively in the Final seniority list of Sr. Assistants finalized vide order 163 AH of 2022 dated 30-05-2022 after issuance of the OPG order vide No. 303 AH of 2021 dated 02-07-2021 and the officials were confirmed as per the position and hierarchy as reflected in the tentative seniority list issued vide No. MC-HS-09/Est-III/061/1842-54 dated 27-06-2024 on the recommendations of the Departmental Promotion Committee.
- (b) That the case of the official was discussed and deliberated in detail and was referred to the administrative department with full factual report vide No. MC-HS/Est-III/2024/467-70 dated 23-04-2024 on the basis of previous representation of the official. However, the claim of the official was found devoid of any merits at this time.
- (c) That the full factual report of the case stands already deliberated by passing consideration order in this regard in the case titled Khalid Bashir Wani Vs Health and Medical Education, J&K. However, the claim of the officials was found devoid of any merits as per the standing rule position.
