Medical College Srinagar within a period of 21 days from the date of issuance of this order, failing which they shall forego their right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of following certificates in original to be verified subsequently:

- Date of Birth Certificate. a.
- Qualification Certificate. b.
- C. Domicile Certificate.
- Medical Fitness Certificate from Chief Medical Officer (CMO) concerned. d. e.
- No Objection Certificate from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate(s) have taken loan for self employment from DIC/Employment Department, they shall relinquish the proprietorship of Unit/Enterprise and also stakes if any in such self employment unit/enterprise before joining the Government Service. They shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from their salary, DDO concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of Proprietorship and stakes , if any, in such self employment unit Enterprise and recovery to be made and also personally monitor its recovery.

The appointment of the above candidates shall further be subject to following conditions:the

- The salary of the appointee(s) shall not be drawn and disbursed to them unless and 1. until, satisfactory reports in respect of genuineness of qualification/Date of Birth/relevant category (if any) are received from the concerned authorities/agency. 2.
- The appointment of the candidates shall be governed by the New Pension Scheme as notified vide SRO-400 dated: 24-12-2009. 3.
- The appointees shall be on probation for a period of two years.
- The interim arrangement, if any, made against the above post shall be deemed to 4. have been terminated forthwith. 5.
- The appointment in Divisional Cadre is non transferable from one Division to another or from one Medical College to another. 6.
- The appointment of the above appointees shall be subject to outcome of writ petitions, if any, pending on subject in any court of competent jurisdiction.

The inter-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against them in the selection list furnished by





The appointee(s) shall give an undertaking in the shape of an affidavit duly attested 8. by 1st Class Judicial Magistrate to the effect that if on verification, their qualification/date of birth/reserved category certificate (s) from the concerned issuing authorities are found fake/forged, their appointment as Laboratory Assistant in Govt. Medical College and Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against them. He/She in that case will not claim for any dues from Govt. Medical College Srinagar.
