Sub: Engagement of Mental Health Nursing Tutor Level-6 (35,400-1,12,400) on Academic Arrangement Basis under S.O. 364 of 2020 dated: 27.11.2020 advertised vide Notice No: 04-NGS of 2022 dated: 07.05.2022.

Pursuant to selection list issued vide notification No: NGS/MC/22/360-65 dated:- 10.06.2022, **Ms. Ruqeeb Jan D/o Bashir Ahmad Khan R/o Kulangam bagh kupwara.** is hereby provisionally engaged as Mental Health Nursing Tutor in the pay Level-6 (35,400-1,12,400) on Academic Arrangement Basis in terms of S.O. 364 of 2020 dated: 27.11.2020 in Govt. Medical College, Sgr. for a period of one year only or till such time the post is filled up by the competent authority on regular basis whichever is earlier:-
2. The terms and conditions of the engagement are as under:-

A	Pay scale and salary	(I). Consolidated pay equal to the revised basic pay, which corresponds to the minimum of the Pay Level-6 (35400-112400) plus Dearness Allowance. (II). Engagee shall also be entitled to HRA as applicable to in-service candidates carrying the minimum of revised scale subject to the fulfillment of conditions provided under relevant rules in this regard. (III). Engagee shall not be entitled to any other monetary benefits, whatsoever.
B	Date of commencement of one year appointment	Date of signing of agreement.
C	Other Conditions of Service	Engagement shall be terminable on either side by prior notice of one month or payment of one month's salary by the appointing authority in lieu of prior notice. Engagement shall be terminable without any further notice, whenever the posts are filled - up under rules) by the competent authority) and the appointee shall have no claim , whatsoever, against the Government or the Appointing Authority. In the matter of discipline and conduct, engagee shall be governed by the rules, regulations and orders in vogue in the Union Territory Service on the subject.



D	Agreement to be signed	Engagee shall be allowed to join only after she signs an agreement as per format prescribed as Form-A appended to S.O. 364 of 2020, dated:- 27.11.2020.
E	Nature of engagement	The engagement made herein shall and shall always be on Academic Arrangement Basis only without conferment of any preferential right on the engagee for regular appointment against the post of Mental Health Nursing Tutor.

3. The engagee shall report to the office of the undersigned within a period of Twenty one (21) days failing which she shall forego her engagement, which shall be deemed to have been cancelled ab-initio without any further notice.
4. she shall be allowed to join only on the production of the following documents/certificates in original:-
- I. Date of Birth & Degree Certificate (M.Sc Nursing).
 - II. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
 - III. Domicile Certificate.
 - IV. Health Certificate from the Standing Medical Board.
 - V. Agreement as per format prescribed as Form-A appended to S.O. 364 of 2020, dated: - 27.11.2020.
 - VI. An undertaking in the shape of an affidavit duly attested by the IST Class Magistrate to the effect:-
 - a. That in case an adverse report about her Qualification, Date of Birth, Marks certificates and Domicile certificate etc, if any, is received from the competent authority to whom the references shall be made by the Controlling Officer, the candidate shall have no right to claim for her engagement as Mental Health Nursing Tutor and her engagement as such shall be deemed to have been cancelled ab-intio. She will not also claim for any dues from Govt. Medical College, Sgr. as well in that case.
 - b. That she has fully understood the terms, conditions and nature of *her* engagement and will not claim for regularization after completion of the term or at any point of time.
5. Character and Antecedents have already been got verified from CID Department vide Form No:- 21, dated:- 31-08-2022, which states that there is nothing adverse against Ms. Ruqeeb Jan.





6. The engagement shall be governed by the other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.
7. The Services of the engaged person shall be terminated in case his performance is not satisfactory/up-to the mark.
8. The concerned DDO shall keep the salary of the aforesaid contractual staff on hold till verification of all relevant documents.
9. One month's salary of the incumbent shall not be paid till completion of the term of engagement as such in terms of existing S.O. 364 of 2020.
