They will carry alongwith their Admit Cards and any one the following documents as proof of their identity;

- c) PAN Card/Aadhar Card

INSTRUCTIONS:

- 1. - 4. Place the admit card and valid ID card on the desk throughout the examination.

- 6. Use only blue or black ball pen to fill the details and responses on the OMR sheets.
- 7. Read the instructions thoroughly on the question booklet and OMR sheet.
- 8. Make sure that you have completely and correctly written your Roll Number and other required details on the OMR sheet.
- 9. The candidates shall restrain themselves from sharing any other materials or communicate with or seek help from other candidates during the test.
- 10. Avoid stray mark or writing anything on any part of the OMR sheet.
- 11. Use the blank page of the question booklet for rough work, if need arises.
- 12. Use of whitener, eraser, nails, rubber, blade, etc. on the OMR sheet is completely prohibited.
- 13. Stop writing and tear off the strip at the perforation line on the top of the OMR sheet to separate carbon copy from the original OMR sheet without damaging edges of the OMR sheet and handover the original copy of OMR sheet to the invigilator after stipulated time is over. You must not leave your seat until all OMR sheets are collected and counted by the invigilator.
