Pursuant to this office Notification No. 22-RA of 2026 Dated. 31.07.2026 and on the basis of Satisfactory verification report of Character & Antecedents by Criminal Investigation Department (CID), J&K, Dr. Sajad Ahmad Khoja, MS, not In-service candidate is provisionally engaged as Senior Resident in the Department of General Surgery on Academic Arrangement basis under S.O. 364 of 2020 Dated. 27.11.2020 and Government Order No. 383-JK (HME) of 2024 Dated. 20.06.2024 initially for a period of one year, which is extendable upto maximum period of **(02) years and (03) months only**, on the basis of good performance to be certified by concerned HOD, in order to complete remaining portion of Senior Residency, as the doctor has sworn on experience certificate as well as on affidavit that he has earlier completed (09) months of Senior Residency at Al-Falah School of Medical Science & Research Centre, Faridabad.

The appointment of the above doctor is further subject to the following terms and conditions: -

1. The selected candidate is supposed to submit his joining report alongwith affidavits in the office of the undersigned duly attested by the Judicial Magistrate to the effect that: -
 - a. He is not In-service candidate, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
 - b. He will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeds on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - c. He shall remain disciplined during the whole tenure; any kind of misconduct shall make him liable for termination without any prior notice.

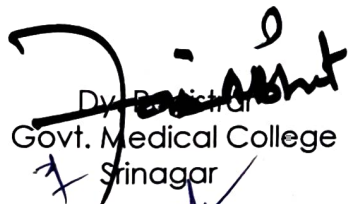
- d. He is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
 - e. He shall not claim any experience certificate in case he leaves Senior Residency before completion at least of six months.
 - f. He will not indulge in any private practice. In case he is found doing private practice; his appointment shall be liable for termination without any notice.
 - g. He shall not claim for further extension beyond (02) Years & (03) months tenure under any circumstances.
2. The above doctor shall have to execute an agreement with the institution on the prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be downloaded from the official website of Government Medical College, Srinagar.
 3. The appointee is required to join within (21) days from the date of issuance of this order; failing which the order shall be deemed to have been cancelled.
 4. The Senior Resident appointed on an Academic Arrangement Basis shall be paid as per S.O. 364 of 2020 Dated. 27-11-2020.
 5. The Senior Resident appointed on Academic Arrangement Basis shall be entitled leaves as per the Government Order No. 451-JK (HME) of 2024 Dated. 08.07.2024.
