Accordingly the above named candidates are directed to report to the Medical Superintendent, Govt. Psychiatric Diseases Hospital, Govt. Medical College, Srinagar for further duties.

## **Terms and Conditions:**

- 1. The engagees shall have to join their assignment within a period of (07) days from the date of issuance of this order, failing which their engagement as such shall be cancelled without any further notice and orders thereof will be issued in favour of the applicant(s) falling in the waiting list.
- The staff, as above, hired on contract basis under the scheme of Psycho Social Programme of UNICEF shall be engaged for a period upto 31<sup>st</sup> December, 2022.
- 3. These are purely programme positions and engagements are not being made against any substantive Government position. Engagement on these positions will in no case translate into a claim for permanent employment or employment in the Govt. Sector.
- 4. The hired persons shall be allowed to join only on furnishing an undertaking in the shape of an affidavit to the effect:
  - i. That in case an adverse report about his/her Character and Antecedents, Qualification, Date of Birth, Marks Certificates and Domicile Certificate etc, if any, is received from the Competent authority to whom the references shall be made by the Medical Superintendent, the candidate shall have no right to claim his/her engagement as Clinical Psychologist/ Advocacy Coordinator/Counsellor and his/her engagement as such shall be deemed to have been cancelled ab-intio. He/She will not also claim for any dues from Govt. Medical College, Srinagar as well in that case.
  - ii. That he /she has fully understood the terms, conditions and nature of his/her engagement in IMHANS under aforementioned scheme and will not claim for regularization after completion of the tenure or at any point of time.
- 5. The Medical Superintendent Psychiatric Diseases Hospital shall allow the hired persons to join only on production of the following documents to be verified subsequently:
  - a) Date of Birth Certificate
  - b) Domicile Certificate
  - c) Qualification Certificates
  - d) Technical Qualification certificates
  - e) No loan certificate from the DIC/Employment department, and
  - f) Any other document as required under rules.
- 6. The temporary engagement of persons is subject to the outcome of writ petition, if any pending in the Hon'ble Court of law.
- 7. The engagement shall be governed by the other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.

- 8. The concerned DDO shall keep the salary of the aforesaid contractual staff on hold till the completion of all the requisite formalities/verification of their documents.
- The engagement will only be for the sanctioned term (i.e.) 31<sup>st</sup>
  December, 2022) subject to the satisfactory performance of the
  candidates/approval of the competent authority.
- 10. The engagee shall have to execute an agreement to the effect that he/she will not leave the Department before the completion of the sanctioned term. Abandonment/termination of the arrangement will require one month's prior notice on either side, failing which the remuneration shall not be paid for one month to the incumbent, which shall always remain in deposit with the Department and shall be released on the completion of sanctioned term. However, the engagement shall be terminable without notice if the scheme gets closed before 31st December, 2022.
