6. The hiring shall be governed by other terms and conditions as are not specifically mentioned herein but are made applicable in case of such appointments at any time willfully by the contracting authority.
7. The candidature shall be cancelled in case it is found at any stage of hiring that any fact has been misrepresented or misconceived or any fraudulent certificate/s has been produced to avail the engagement.
