
Pursuant to the recommendations of Selection Committee which met on 26th September 2022 and verified the antecedents from Criminal Investigation Department (CID), Dr. Manjote Kour Sahni, MS, not an In-service candidate, who has applied for the post of Demonstrator in the Department of Anatomy, Government Medical Srinagar is provisionally engaged as Demonstrator on Academic Arrangement basis initially for a period of one year which is extendable upto (03) years on basis of good performance to be certified by the concerned HOD.

The tenure of above selectee is on academic arrangement basis and will be governed by the rules and regulations as envisaged in S.O. 364 of 2020 Dated. 27-11-2020.

The appointment of the above doctor is further subject to the following terms and conditions:-

1. Before joining the Department the selected candidate shall submit an affidavit in the office of the Demonstrator Academics, Government Medical College, Srinagar, duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -
 - a. she is not an In-service, the information if found wrong the selectee shall be punished under Rules which includes confiscation of the Registration of the Doctor.
 - b. she will not participate in any kind of strike during the period of her tenure engagement. In the event she proceeded on strike, her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.

- c. she shall remain disciplined during the tenure period, any kind of misconduct make her liable for termination without any prior notice.
 - d. she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against her.
 - e. she shall not claim any experience certificate in case she leaves Demonstratorship before completion of first year.
 - f. she will not indulge herself in any private practice. In case she is found doing private practice her appointment shall be terminated without any notice.
2. The above not an In-service candidate doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be downloaded from the official website of Government Medical College, Srinagar.
 3. The appointee is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled. The selected candidate is supposed to submit his joining report in the office of the Demonstrator Academics, Government Medical College, Srinagar before he will be directed to report to the concerned Department.
 4. The Demonstrator appointed on Academic Arrangement basis shall be paid as per S.O. 364 of 2020 Dated. 27-11-2020.
