This is for information of all the Principals of AMT / ANMT Schools, (Government and Private-) that the Regular examination for the Session Oct-Nov- 2023, of Para-Medical and Nursing Trainees (Jammu & Kashmir Divisions, including Leh & Kargil) shall be conducted in the month of December-2023. As such all concerned Principals are enjoined to submit examination forms of all eligible candidates with the following instructions:-

- ❖ That they shall submit the examination forms of all fresher eligible candidates selected by BOPEE and other eligible failure & Carry on Candidates (in case of GNM Course) by or before 30.11.2023 for the Examination Session Oct- Nov 2023 , along with necessary documents & examination fee @ Rs.1000 per Candidate in the shape of Bank Slip Only. The last date for accepting forms with a late fee of Rs. 500 /- is 05 - 12 - 2023.
- ❖ That the Principals of the Concerned AMT / ANMT Schools and Private Para-Medical Institutes should verify that the examination forms of eligible candidates are sent along with the prescribed fee to the council as per rules.
- ❖ That the Principals of concerned AMT / ANMT Schools , while submitting the examination forms will examine and certify the eligibility of the candidates in respect of age , qualification , registration etc. of the candidate as required as per norms.
- ❖ Internal assessment of the candidates should be sent with the examination Forms along with other particulars such as Name, Parentage, Address, of each student in a pen-drive and one Hard Copy duly signed by the concerned Principal / Head of the Institution.
- ❖ That the concerned head of the institution should submit the certificate in favour of the Examinees that they have completed their syllabi and have undergone the clinical training for the Particular class which he / she is going to appear.



- ❖ That the Head of the concerned Institution will enclose a certificate to the effect that the examinee has got not less than 80% of attendance (Both in Theory and Practical).
- ❖ That the Head of the Institute shall ensure to fill up the soft copy with Proper details viz Name, Parentage, Residence, Name of the Institute and Previous Year Roll Number etc.
- ❖ Candidate(s) shown Compartment or had remained Absent in any subject Viz , C-I , C-II , C-III and C-IV , or Ab-I , Ab-II, Ab-III shall have to submit the examination form separately for compartment subjects along with the requisite fee.
- ❖ The Date sheet for the examination will be notified separately.
