The appointment of the above doctors is further subject to the following terms and conditions: -

1. Before joining the Department, the selectees shall submit an affidavit duly attested by the Judicial Magistrate/first class Magistrate in the office of the Registrar/Demonstrator Academics, Government Medical College, Srinagar to the effect that: -
 - a. he/she will not participate in any kind of strike during the period of his/her tenure engagement. In the event he/she proceeded on strike, his/her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 - b. he/she shall remain disciplined during the tenure period, any kind of misconduct make him/her liable for termination without any prior notice.
 - c. he/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him/her.
 - d. he/she shall not claim any experience certificate in case he/she leaves Registrarship/Demonstratorship before completion of first year.
 - e. he/she will not indulge herself in any private practice. In case he/she is found doing private practice his/her appointment shall be terminated without any notice
2. The above doctors shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement.

3. The appointee is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled. The selected candidate is supposed to submit his/her joining report in the office of the Registrar Academics, Government Medical College, Srinagar before he/she will be directed to report to the concerned Department.
4. The Registrars/Demonstrators appointed on Academic Arrangement basis shall be paid as SO. 365 of 2020 Dated. 27-11-2020.
