## **ORDER**

Subject: Hiring services of Medical Officer for DTC, IMHANS-K

Reference: Advertisement Notice no. 01 of 2022, dated 26.08.2022

Whereas, interview for the post of Medical Officer, Counsellor & Nurse on contract basis for Drug Treatment Centre (DTC) being run at IMHANS-K was conducted on 18<sup>th</sup> October, 2022 at 10:30 a.m. in the office chambers of Head of the Department, IMHANS-K advertised vide notification No. Psy/2022/Adv/DTC/401-08, dated: 08 OCT, 2022 through Print & Electronic Media; and

Whereas, Selection List for the above mentioned posts based on the selected list in the interview prepared by the duly constituted board was published vide notification No. Psy/2022//DTC/SL/412-18 Dated: 21, Oct 2022; and

Whereas, the selected candidates for the above posts were advised to join the department along with requisite testimonials for fulfillment of pre-requisite formalities within 07 days from the date of publication of the selection list; and

Whereas, one of the selected candidates namely Dr. Farishta Khurshid, D/o Khurshid Ahmad Chaku, R/o Ishber Nishat, Srinagar after joining the department on 25th October, 2022 against the post of Medical Officer withdrew her joining and resigned from the said post on 12th November 2022 due to her selection for MD Pathology in ASCOMS, Jammu and accordingly, her selection was cancelled; and

Whereas, consequent upon the above and considering the vacancy which accrued as a result of resignation given by Dr. Farishta Khurshid against the post of Medical Officer; the candidate featuring at the top of the operated waiting list namely Dr. Fozia Ashraf, D/o Mohammad Ashraf Wani, R/o New Colony Sopore, Baramulla is hereby selected for the post of Medical Officer subject to fulfillment of prescribed formalities.

## Her services will be governed by the following terms & conditions:

- The selection is purely provisional, subject to prejudice by the outcome of verification of the certificates.
- 2. The candidate shall report to the office of the undersigned within seven days from the date of issuance of this order positively along with all requisite

original documents for verification, failing which waiting list shall be considered.

- The hiring is purely on contractual basis for a period of one year and may be renewed further based upon the performance of the candidate and subject to approval of the post by MoH&FW.
- 4. The contractual hiring shall not confer any right on the appointee to claim extension or for regular selection at any time.
- 5. The hiring shall be governed by other terms and conditions as are not specifically mentioned herein but are made applicable in case of such appointments at any time willfully by the contracting authority.
- 6. The candidature shall be cancelled in case it is found at any stage of hiring that any fact has been misrepresented or misconceived or any fraudulent certificate/s has been produced to avail the engagement.
- 7. The candidate shall have to give one month prior notice before leaving the contractual services or else his/her one month salary will be forfeited for which the candidate shall have no claim.
