



The terms and conditions of the engagement are as under:-


1	Pay scale and salary	<ul style="list-style-type: none"> <li>➤ The engagees shall be paid consolidated pay equal to the revised basic pay, which corresponds to the minimum of the Pay Level-4 (25500-81100) plus Dearness Allowance.</li> <li>➤ The engagees shall also be entitled to HRA as applicable to in-service candidate carrying the minimum of revised scale subject to the fulfillment of conditions provided under relevant rules in this regard.</li> </ul> <p>The engagees shall not be entitled to any other monetary benefits, whatsoever.</p>
2	Date of commencement of engagement	Date of signing of agreement.
3	Other Conditions of Service	<p>Engagement shall be terminable on either side by prior notice of one month or payment of one month's salary by the appointing authority in lieu of prior notice. However, the engagement shall be terminable without any further notice, whenever the post is filled up under rules by the competent authority and the engage shall have no claim, whatsoever, against the Government or the Appointing Authority.</p> <p>In the matter of discipline and conduct, the engage shall be governed by the rules, regulations and orders in vogue in the Union Territory Service on the subject.</p>
4	Agreement to be signed	Selected candidate shall be allowed to join only after he/she signs an agreement as per format prescribed as Form-A appended to S.O. 364 of 2020, dated:- 27.11.2020.
5	Nature of engagement	The engagement made herein shall and shall always be on Academic Arrangement Basis only without






		conferment of any preferential right on the engagee for regular appointment against the post of Jr. Grade Nurse.

- 06). The above engaged candidates shall report to the Office of the undersigned within 21 days from the date of issuance of this order, failing which the engagement shall be deemed to have been cancelled ab-initio without any further notice.
- 07). The engagees shall be allowed to join only on production of the following certificates in original and signing of the requisite agreement:-
- i. Matriculation (Date of Birth) Certificate;
  - ii. Domicile Certificate;
  - iii. 12<sup>th</sup> Class Marks Certificate;
  - iv. Diploma/ Degree Certificate;
  - v. Diploma/Degree Marks Certificate (Year Wise).
  - vi. Category Certificate, in case of reserved category candidates;
  - vii. N.O.C from concerned District Industries Centre & Employment Exchange.
  - viii. Agreement as per format prescribed under S.O. 364 of 2020, Dated: - 27.11.2020 duly attested by the Ist Class Judicial Magistrate.
  - ix. An undertaking in the shape of an affidavit duly attested by 1<sup>st</sup> Class Judicial Magistrate to the effect:-
    - i) That in case any adverse report about Qualification, Date of Birth, Marks certificates, Reserved Category certificate, Domicile Certificate etc, if any, is received from the competent authority to whom the references shall be made by the concerned DDO, the candidate shall have no right to claim his/her engagement as Jr. Grade Nurse & his/her engagement as such shall be deemed to have been cancelled ab-initio. He/she will not also claim for any dues from Govt. Medical College, Sgr. as well in that case.
    - ii) He/she has fully understood the terms, conditions and nature of their engagement in Govt. Medical College, Srinagar on academic arrangement basis and will not claim for regularization after completion of the term or at any point of time.
- 08). The Character/Antecedents of these candidate have already been got verified through Criminal Investigation Department and the concerned DDOs shall get all other relevant certificates verified from the concerned agencies.





- 09). The engagement shall be governed by the other terms and conditions, as are not specifically mentioned herein this order but are made applicable in case of such engagements any time by the contracting authority.
- 10). The services of the engaged persons shall be terminated in case their performance is not satisfactory/upto the mark.
- 11). The respective DDOs shall keep the salary of the aforesaid contractual staff on hold till the completion of all the requisite formalities/verification of documents.
- 12). The above engagement shall be subject to the outcome of the writ-petition, if any, pending before the Hon'ble court of law.
