It is for the information of all the concerned that Govt. Medical College intends to hold an exhibition of books on medical subjects from 14th December till 16th December 2023 at Central Library, Govt. Medical College Srinagar.

The interested book suppliers/publishers may confirm their participation after fulfilling the necessary submission guidelines (Terms & Conditions), latest by 11th December 2023.

Terms & Conditions:

Part A:

- i. The Committee constituted for, reserves the right to approve or reject the participation on the basis of the merit laid down in the terms and conditions.
- ii. Ensure all the documents are submitted in digital format (pdf or word), clearly labeled with publishers name.
- iii. Email your submissions to **librariangmcs10@gmail.com** by the submission deadline. Late submissions will not be considered.
- iv. Distribution of orders to the participant suppliers is purely based on terms and conditions, technical requirements laid down to the successful firms/agencies approved by the committee constituted for.
- v. Each publisher will be provided with a designated space to showcase their publication and hence forth bring the promotional materials for display to enhance your presentation.
- vi. Security Deposit of Rs 50,000 (Fifty Thousand Only) in the shape of CDR/FDR is to be submitted, pledged to the Chief Accounts Officer, Government Medical College, Srinagar after the placement of order.
- vii. Registration certificate with Indian Publisher Association to be furnished well in time.
- viii. Non-Blacklisting Declaration duly attested by Judicial Magistrate with the content that the firm has not been blacklisted in the past by any government or private institution of the country and there is no vigilance/any other investigation/case pending against the firm/supplier.
- ix. Authority letter from the principle publishers on the letter head of the manufacturing firm duly signed and stamped by a competent person.
- x. Undertaking letter of acceptance.
- xi. Valid GST Clearance Certificate.

Part B:

Discount/Concessional rates offered by the publisher, as admissible, shall be included in the proposal after the commencement of exhibition.

Bill/ invoices are to be submitted in triplicate (computerized only) mentioning the full title along with edition, year of publication, price of book, percentage of discount, number of copies and total net price.

Only original copies shall be kept to display and pirated/defective/photo-copies shall not be accepted at all.

The participant supplier has to submit the price proof/publishers catalogue/original invoice of publisher for the verification of the cost of book.

Payment will be made after completing of the supply order and will be released after successive billings, as and when.

Conversion rate of the foreign titles will be as per the latest GOC Circular as prevailing at the time of supply of books.

Participant Publishers shall be responsible for delivering physical copies of their selected books to the exhibition venue.

The prices in the invoice should be indicative of the original currencies.

Invoice should be raised in favour of the Chief Librarian, Central Library, Govt. Medical College Srinagar.

A certificate should be appended by the supplier on the body of the bill /back side of the bill (last page) as follows:

Undertaking:

This is to certify that:

- Books are supplied in good condition and are original
- Books are supplied only latest edition/latest year of publication and are not old edition.
- Prices of the books are charged correctly in accordance with publisher's catalogue price.

Part C: Penalties:

In event of the involved supplier failing, declining (without assigning any valid reason) or in the event of any damage occurring or being caused by supplier, the Government shall without prejudice to any other remedy available to it under the law for the time being in force in J&K UT:

a. Recover the amount of loss caused by damage, failure or default

(Including the Consequential damages)

b. Impose a penalty up to 10% of the proportionate value of the order.

Part D: Arbitration:

If at any time, any question difference or dispute whatsoever arises between parties hereto or in relation to a part thereof, either of the party may give to other notice in writing of the existence of such a question or

dispute or difference and same shall be referred for award to two arbitrators, one to be nominated by the College and the other by the supplier, or in case of such arbitration, not agreeing then the award or an "umpire" appointed by the arbitrator in writing before proceeding with the case. The decision of the arbitrators/Umpires shall be final and binding on the parties.

The provision of J&K Arbitration Act 2002 and of the rules there-under and any statutory modification thereof shall be deemed to apply to arbitration.

Jurisdiction for all arbitration cases or legal cases shall be under the jurisdiction of Srinagar (J&K) courts only.


