Subject:- Revised Tentative Seniority list of **Community Health Unit** of Government Medical College and Its Associated Hospitals Srinagar as stood on 01-12-2025.

**NOTIFICATION**

Whereas, vide this office Notification No. GMCS/HS/2025/5035-42 dated 04-11-2025, a tentative seniority list of the Community Health Unit [Viz. Field officer, Level-7 (44900-142400), Technical Assistant/Community Health Officer/Food inspector, Level-6F (40800-129200), Sr. Public Health Assistant, Level-6E (35900-113500), Public Health Assistant Level-6D (35800-113200), Public Health Assistant/Lady Health visitor/Health Educator/Health Inspector/T.B.H. visitor Level-6 (35400-112400) & Basic Health Worker, Level-4 (25500-81100)] of Govt. Medical College and its Associated Hospitals Srinagar was issued/notified on the basis of Service Bio data/records available in this office as per the executive order issued by the Government vide order No: 456 JK(HME) of 2023 dated 02-06-2023 for information of all the cadre members for inviting objections/representation(s) through proper channel supported with sufficient documentary proof within a period of (10) ten days; and

Whereas, following representations were received by this office till date:-

01. Head of Department SPM, GMC Srinagar vide No: SPM/1042 Dated: 10.11.2025 has forwarded representation of Mr. Mohd Yousuf Mir, Community Health Officer wherein he has represented against the seniority status of Mr. Mohd Farooq Wani, Community Health Officer with the objection that the Diploma certificate of the official appears to be acquired by him during Adhoc service period and is inconsistent with eligibility criteria and has requested for examination and rectification of seniority list.
02. Another representation was received from Mr. Farooq Ahmad Bhat (TBH visitor), Showkat Ahmad Sheikh (Basic Health Visitor), Hameeda Lone (Lady Health Visitor) & Shaziya Maqbool (Basic Health Visitor) wherein they have objected to incorporation of new officials in the seniority list and has requested for examination and rectification of seniority list.
03. Another representation was received from Mr. Manzoor Ahmad Dar representing therein that the officials figuring at S. No 01 and S. No 02 in Level-6F both designated as Community Health Officers were inducted to Level-06 on 07-09-2010 and 24-01-2011 respectively however, he was inducted on 12-12-2003 as TB Health Visitor in Pay Level-06 and has requested for examination and rectification of seniority list.
04. Another representation was received from Mr. Abdul Majeed Khan, Basic Health worker requesting therein that Mr. Farooq Ahmad Bhat has been promoted in the higher post of Level-06 and figures at S. No. 05 in the category of Health Educator. However the representee shown in kept in pay Level-4 and has requested for rectification of seniority list.

Whereas, objections/representations were examined with reference to relevant records /under the touch stone of rules in vogue and were redressed/disposed as follows:

01. The representation/objection of Mr. Mohd Yousuf Mir, Community Health Officer has already been taken up with Head of Department SPM, Govt. Medical College Srinagar vide this office letter No: GMCS/E3/2025/6103-6105 Dated: 11-11-2025 and the reply/report is still awaited. As such the list shall not be altered in anticipation of report from the concerned quarter.
02. That the tentative seniority list of the category has been framed and issued as per the Govt. Order No: 456- JK (HME) of 2023 dated: 02-06-2023 wherein Public Health Assistant/Lady Health visitor/Health educator/Health inspector/ TBH Visitor of (Level-06) have been incorporated in Community Health as a single Unit. As such the claim of the officials is devoid of any merits, hence rejected.
03. That Mr. Manzoor Ahmad Dar, TB Health Visitor, stands at serial No. 01 in the tentative seniority list in Level-06 whereas the officials figuring at S. No 01 and 02 as Community Health visitors figures in Level-07 of the seniority list. As such the claim of the official is devoid of any merits, hence rejected.
04. That after examination of the records it has been come to fore that the DPC held in the year 2022 has passed the decision in favour of the official which is reproduced as under:-

"An FIR under No. 29/2015 U/S 420,467,471,1208 RPC stands registered against the official in police station Sumbal kashmir and the case is subjudice as on date. In light of the above facts, it is suggested that we may keep one post of Health Educator reserved for the said official carrying pay scale 6( 35400-112400) till the case is settled at Govt. Children hospital Srinagar caused vacant due to retirement of Fayaz Ahmad shah on 31-04-2018"


As per records the case is still subjudice and has neither been disposed nor has this office received any communication regarding the matter till date. As such the claim of the official is devoid of any merits, hence rejected.

In view of above revised tentative seniority list the Community Health Unit [Viz. Field officer, Level-7 (44900-142400), Technical Assistant/Community Health Officer/Food inspector, Level-6F (40800-129200), Sr. Public Health Assistant, Level-6E (35900-113500), Public Health Assistant Level-6D (35800-113200), Public Health Assistant/Lady Health visitor/Health Educator/Health Inspector/T.B.H. visitor Level-6 (35400-112400) & Basic Health Worker, Level-4 ( 25500-81100) of Govt. Medical College and its Associated Hospitals Srinagar on the basis of Service Bio data/records available in this office as per the executive order in vogue issued by the Government vide order No: 456 JK(HME) of 2023 dated 02-06-2023 is hereby issued as **Annexure "A"** for information of all the cadre members for inviting objections/representation(s) through proper channel supported with sufficient documentary proof within a period of (10) ten days from the date of issuance of this notification. Objections received after stipulated date shall not be entertained.

The Controlling Officer(s) shall circulate a copy of revised tentative Seniority List among each cadre member(s) on his/her establishment(s) and furnish a No Objection certificate in this regard. The said list shall also be available on our official website [www.gmcs.edu.in](http://www.gmcs.edu.in)

The revised tentative seniority list shall be prejudice to the outcome of any writ petition (if any) pending before any competent court of Law.

The date of Birth and Category status of the official(s) reflected in the revised tentative seniority list shall be subject to the further verification from the service Book(s)/ Matriculation certificate(s)/category certificates issued in respect of these officials by the competent authority.
